New Zealand

The New Zealand Society for Computers and the Law is in its fourth year, having originally been formed in 1987. Incorporation of the Society under the Incorporated Societies Act 1908 has recently been completed.

There has been substantial interest in the Society from lawyers and computer professionals outside Wellington, particularly in Auckland and Christchurch. At the Annual General Meeting on 26 February 1991, the way was paved for the official formation of branches in Auckland, Christchurch and Dunedin with the election of representatives from these regions. Seminars

The Society's inaugural seminar - *Desktop Ltttgatton: Ltve!* - held at the Brisbane Hilton on 3 April, 1991 was a great success. Over 100 registrants witnessed an impressive demonstration by Arch Fletcher and Robert Wensley of the use of a litigation support system in a complex arbitration involving large amounts of evidentiary material. The quality of the seminar reflected the high degree of preparation undertaken by the presenters to whom the Society once again expresses its gratitude. The assistance of Henderson Trout in providing the hardware, software and projection equipment was also much appreciated.

The next seminar will be conducted jointly with the Law Faculty of Queensland University of Technology on 18 June on the topic *An Introduction to Computer Hardware and Software for Lawyers*. As in the case of the first seminar, this will be very much a demonstration of the computer applications presently available for the legal profession. As the title suggests, the seminar will be aimed at an introductory level.

Members' Discussion Groups

A Members' Discussion Group has been formed and will meet on a regular basis to discuss computer-related topics. The object is to provide a forum in which members may discuss current topics. Whilst the Group's agenda will not be limited to intellectual property-related topics, those topics will be better suited to the discussion approach. Attendance at the meetings is limited to members. The first discussion meeting was held on 13 May 1991 to discuss *Copyright in Computers Software: The State of Play.* A further meeting has been planned for 1 July 1991 to discuss *Revenue Law Aspects of Technology Transactions.*
