

Research into the use of the Internet at home

The ABA and NetAlert Limited have invited proposals to conduct research into the use of the Internet in Australian homes. The research will obtain information about how families with children aged approximately 9 to 13 years use the Internet at home and how they manage the potential risks.

The research will build on a study undertaken by the ABA in 2001. At that time, the coregulatory Internet content scheme established under Schedule 5 to the Broadcasting Services Act had only recently commenced and fewer than than one-third of Australians were connected to the Internet at home. With more than one-half of Australian households now online, and the co-regulatory scheme in operation for more than four years, the new study will enhance the ABA's and NetAlert's understanding of the contemporary online environment, and assist in the application of appropriate and effective strategies to educate children and parents about online services.

The research will investigate the behaviours and attitudes associated with Internet use in the home, providing valuable information concerning behaviours and attitudes with respect to traditional modes of Internet use such as World Wide Web browsing via a fixed Internet connection. It is also intended that the research will explore the behaviours and attitudes of children and parents in response to recent Internet developments, as well as the impact that mobile Internet use has on families' management of Internet access.

The call for submissions, which closed on 13 July 2004, attracted proposals from ten



research consultants. It is expected that the successful consultant will commence work by the end of August and that a final report containing the research findings will be completed in December 2004.

Changes proposed for services
