# Adjudication

### **Authorisations**

The Commission has the function, through the authorisation process, of adjudicating on proposed mergers and certain anti-competitive practices that would otherwise breach the Trade Practices Act.

Authorisation provides immunity from court action and is granted if the Commission is satisfied that the practice delivers offsetting public benefits.

#### **CSR** Limited

In relation to the rostering provisions which establish the system for the distribution of CSR's cartage work among its carriers in WA (A90769)

- Draft determination issued 6 November 2002
- Final determination issued 3 February 2003

The Commission will allow CSR Limited and its Western Australian independent concrete carriers to agree to a concrete cartage job allocation system.

The Commission has found the public benefits gained from the allocation system are likely to outweigh the anti-competitive detriment. In a final determination, it has granted authorisation to the arrangement for five years.

In particular, the Commission believes the possible anti-competitive effect of the arrangement is reduced as it is not industry-wide, only applying between CSR and its Western Australian independent concrete carriers.

The Commission also concluded that the arrangement is likely to result in reduced costs and improved efficiencies. In the circumstances presented, the arrangement should result in improved industrial harmony between CSR and its independent concrete carriers.
