What's new on the bookshelf!

The completely revised Summary of the Trade Practices Act is now available, as is the March 1999 Glass containers monitoring report. The ACCC monitors ACI in relation to the supply of all glass containers and this is the ACCC's second report. Both are available for \$10.

Yet another revision, because of its continuing popularity, is the Misleading job and business opportunity ads which is a manual for classified advertising staff, giving guidance on how to spot and weed out advertisements that may be misleading or, worse, outright scams. The publication is a joint effort between the ACCC, Job Watch and the Australian Publishers' Bureau.

Two free publications are a Corporate trade practices compliance programs — a message from the Chairman of the ACCC to Australian chief executive officers — and a news for business sheet on Self-declared environmental marketing claims which briefly discusses the International Organization for Standardization's draft international standard Environmental labels and declarations — self-declared environmental claims and the application of the Trade Practices Act to such claims.
