NATIONAL CHILDREN'S AND YOUTH LAWS CENTRE

Launched officially in June 1993, the Centre is a joint project of the University of Sydney, University of NSW and the Public Interest Advocacy Centre with 3 year establishment funding from the Australian Youth Foundation. The Centre's basic purpose is to improve the law, legal systems and legal services in order to promote, protect and enforce children's and young people's rights.

Robert Ludbrook, Director of the National Children's and Youth Law Centre, has considerable experience in the field having worked with youth advocacy groups in New

Zealand and England.

The Centre has made submissions to the Commonwealth Government on the Draft Report on the implementation of the UN Convention on the Rights of the Child and on Bills before Parliaments in NSW, Victoria and Northern Territory. A current project is the development of a kit of legal information about children's rights in schools. Research is underway on Standards in Detention Centres and Anti-Discrimination laws as they effect young people.

Report of the 6th ASEAN Paediatric Federation Conference, Denpasar Bali Indonesia, October, 1992.

Countries represented at this conference included Indonesia, Malaysia, The Philippines, Singapore, Brunei and Thailand. There were four presentations from western countries.

Issues covered included child abuse, child labour and the Convention on the Rights of the Child. This latter topic attracted great

attention. National action plans are asked of each country which ratify the Convention and programmes for each country were related to their particular problems and were clearly spelt out.

The Convention on the Rights of the Child and the recent World Summit have had a great impact on South East Asian countries, forcing a real commitment to action. Australia should increase its involvement with those working for children in neighbouring countries.
