The following information is communicated to the Press by the Registry of the International Court of Justice:

The Court has been informed by the Secretary-General of the United Nations that on Wednesday 11 November 1987 the United Nations General Assembly and Security Council have re-elected Judges Ago (Italy), Schwebel (USA), Bedjaoui (Algeria) and Tarassov (USSR) as Members of the Court.

On that same date, Mr. M. Shahabuddeen (Guyana) has been elected to be a Member of the Court as from 6 February 1988

Elections are governed by the provisions of Articles 4 to 12 of the Statute of the Court.

On Tuesday 17 November 1987 the inaugural public sitting of the Chamber of the Court in the case concerning Elettronica Sicula S.p.A. (ELSI) was held.

Speeches were made by President Nagendra Singh who, pursuant to Article 18, paragraph 2, of the Rules of Court, is the President of the Chamber, as well as by the Deputy-Agent of the United States, Mr. T. Ramish and the Agent of Italy, Mr. L. Ferrari Bravo.

By an Order of the same date the Chamber of the Court fixed 18 March 1988 as the time-limit for the filing of a Reply by the United States and 18 July 1988 for the filing of a Rejoinder by Italy.

On Monday 16 November 1987, within the time-limit fixed by the Court in an Order of 2 March 1987, the Agent of Italy had filed the Counter-Memorial.

The following information is communicated to the Press by the Registry of the International Court of Justice:

Today, 24 February 1988, the International Court of Justice elected Judge José Maria Ruda (Argentina) to be its President and re-elected Judge Kéba Mbaye (Senegal) to be its Vice- President.

Their terms of office as President and Vice-President will come to an end in 1991. Their membership of the Court is also due to expire in 1991.

It will be recalled that Judge Kéba Mbaye was elected Vice-President on 6 May 1987 to fill the vacancy caused by the death, on 10 March 1987, of Judge Guy Ladreit de Lacharriere (France).
