
# **Strong Bet**

Which place has the highest proportion of lawyers to population? The US, you say? Not so though could be forgiven for thinking that Dan Quayle asked rhetorically, "Does America really need 70 per cent of the world's lawyers?"

Actually, according to ABA Journal (US), the US is 35th with 28.54 on a list ranking law providers per 10,000 population in 1987. (Australia comes 39th with 24.99, Canada 49th, the UK 52nd, Ireland 57th and Hong Kong 95th, in the list of 100, and Zaire has the fewest law providers with 1.26 per 10,000 population.) Countries with greater proportions of lawyers than the US include Japan, New Zealand, Mexico and Ecuador.

Top of the list, with a staggering 3,482.38 law providers per 10,000 population is Vatican City, followed by Uruguay (180.76) and Lebanon (150.18).
