

Bills introduced during June Assembly sittings

The following Bills were introduced by Attorney-General Daryl Manzie during the June 1994 sittings of the Legislative Assembly:

- * Statute Law Revision Bill 1994.
- * Criminal Code Amendment Bill (No 2) 1994. (This Bill was introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. It was therefore reintroduced in the June sittings.)
- * Domestic Violence Amendment Bill 1994. (This Bill was introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. It was therefore re-introduced in the June sittings.)
- * Choice of Law (Limitation Periods) Bill 1994. (This Bill was introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. It was therefore re-introduced in the June sittings.)
- * State Bank of South Australia (Transfer of Under-

taking) Bill 1994. (This Bill was introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. It was therefore re-introduced in the June sittings. This Bill was passed on urgency in order to enable the transfer of assets to occur on July 1, 1994.)

* Director of Public Prosecutions Amendment Bill 1994. (This Bill was introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. It was therefore re-introduced in the June sittings.)

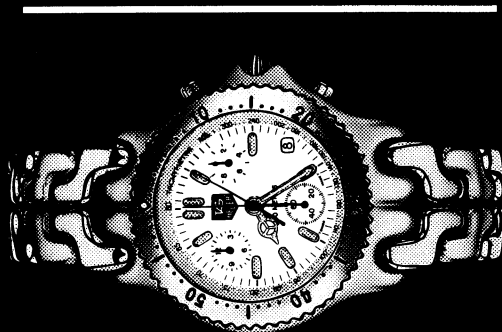
* Misuse of Drugs Amendment Bill 1994 and the Police Administration Amendment Bill (No 2) 1994. (These Bills were introduced in the May sittings and lapsed with the prorogation of the Legislative Assembly. They were therefore re-introduced in the June sittings.)

* Legal Practitioners Amendment Bill 1994. (This Bill had previously been introduced but had lapsed with the prorogation of the Legislative Assembly. It was therefore re-introduced in the June sittings.)

The Sentencing Bill and the Sentencing (Consequential Amendments) Bill were also re-introduced. The Bills, with the exception of the State Bank of South Australia (Transfer of Undertaking) Bill, which has already been passed, and the Legal Practitioners Amendment Bill, are scheduled for passage during the August 1994 sittings of the Legislative Assembly. The Law Society has copies of the Second Reading speeches for each of the Bills.

An inquiry issues paper has been released to assist participants in preparing submissions.

Although the paper is a guide to the questions the commission is seeking to answer, participants should feel free to raise any other issues they consider important.

Submissions may be a letter or a more substantial document.

All submissions are due by August 22, 1994.

Any information that you do not wish to make publicly available should be marked confidential.

However, it is preferable that as much information as possible be made public to ensure all relevant matters can be discussed.

You can assist the commission by providing your submission on a 5.25 or 3.5 inch diskette.

The commission uses Microsoft Word for Windows but can accept a wide range of formats.
