On the other hand, if a member refuels at a site where fuel is being heavily discounted - reducing the price to below your BP Card price - you will only pay the pump price. There is a small transaction fee each time the card is used. There are no surcharges or account fees on your card.

## Full Court Documents

The Full Court usually sits in relation to matters arising under the <u>Legal Practitioners Act</u> and Rules thereunder s21 of the <u>Supreme Court Rules</u>.

There shall be filed in all matters to come before the Full Court, in addition to the original, three copies of all documents.

In any contested matter, not later than 48 hours before the hearing is scheduled to commence in the Full Court, each party shall file three copies of (a) a list of authorities; and (b) a summary of submissions.

Rules 84.18; 84.19; 84.20; and 84.22 of the Supreme Court Rules shall mutatis mutandis apply to applications or referrals to the Full Court.
