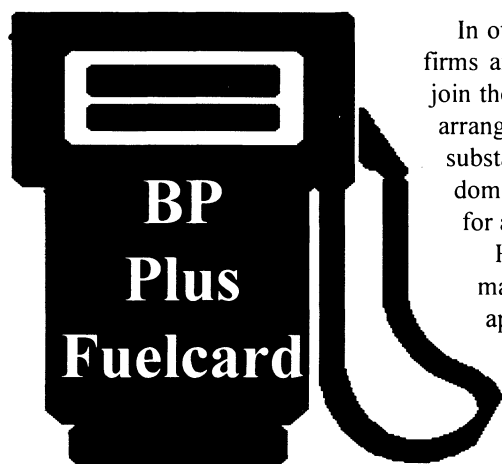


## Member Services Column



Your Law Society has secured a major coup this month by linking with BP Oil to offer members the BP Plus Fuelcard. But you'd better be quick — members only have until 19 May to sign up.

Card holders will automatically be charged the cheapest price for fuel at the time of purchase.

When you head to your nearest BP as a Law Society member, if you find that site is charging more than the BP Card price, you will only pay the Card price.

On the other hand, if a member refuels at a site where fuel is being heavily discounted, — reducing the pump price to below your BP Card price — you will only pay the pump price ... at absolutely no extra cost.

Your BP Card works on a user pays system. There is a small transaction fee each time the Card is used — that's it! There are no surcharges or account fees on your Card.

A monthly statement will be sent to all participating members, with payments conveniently arranged through direct debit.

BP has the largest fuel network in Australia with more than 1800 sites. The Northern Territory now joins Western Australia, South Australia, New South Wales and Victoria in providing this service to Law Society members.

Hundreds of specialised Law Society application forms are now being printed — but you MUST be registered for the deal within the 30 day deadline. To join simply call Vicky at the Society on 81 5104.
