Darwin clinches 'Mock Trial' title

Cross examinations, witnesses' testimony and objections are over until next year for Territory high school students, with Darwin High School being awarded the 1994 Inter-School Mock Trial Competition.


Chief Justice Martin adjudicated the Grand Final at the Supreme Court last week.

Darwin's opponents in the fictitious trial — concerning a contravention of the Dog Act (NT) — were St Philips College, Alice Springs, with St Philips as Prosecution and Darwin High as the Defence. Michael Williams was accused of being the owner of a dog which was not under effective control and in a public place.

The Chief Justice said he was impressed by the efforts of both teams but ultimately decided that the Prosecution had failed to prove the charge beyond a reasonable doubt — thereby awarding the case to the Defence.

Darwin High Team 2 was coached by Ben O'Loughlin (Police Prosecutions) and Therese Austin (Department of Law), while St Philips Team 2 was instructed by Chris Roberts (Director of Public Prosecutions).

This is the fourth time that Darwin High has won the coveted title. Their previous triumphs were in 1990, 1991 and 1993. Other winners have included St Johns College in the inaugural 1989 contest and Sadadeen Secondary College, Alice Springs, in 1992.



Two schools entered the competition for the first time this year — Dripstone High School and Taminmin High School. Along with Casuarina Secondary College, St Johns College (two teams) and Darwin High (three teams), they battled in a series of three knockout rounds before Darwin High's Team 2 emerged as the Darwin finalist.

In Alice Springs, St Philips College (two teams) and Centralian College (two teams) competed in a round robin event, with St Philips Team 2 chosen as the Alice Springs victor based on their total winning points margin over the three rounds.


Chief Justice Martin presented the six Grand Finalists from each side with a plaque, book voucher and certificate at a post-final dinner, while the Perpetual Shield was presented to Darwin High at a formal assembly.

This year's competition was sponsored by the Public Purposes Trust, Qantas Australian Airlines, Angus & Robertson - The Bookshop and the Commonwealth Bank.
