User Friendly Corporate Law

Attorney-General Michael Lavarch recently announced details of the First Corporate Law Simplification Act, heralding a new phase for small business and corporate law. As outlined in the Justice Statement, the government is committed to make the law easier to understand and cheaper to use. Examples of some of the reforms as a result of the Act include revisions in which small proprietary companies will no longer have to prepare accounts for Corporations Law purposes, hold annual general meetings or keep registers.

The Second Simplification Bill, dealing with share capital, financial statements and audit returns, is expected to be introduced early in 1996
