

# Workers' compensation insurers under microscope in new draft report

The Work Health Authority is seeking comments on a draft report concerning workers' compensation insurers in the Northern Territory.

This report, "Monitoring Insurer Performance Under The Work Health Act", considers the performance expected of workers' compensation insurers and suggests major changes to the future approval and monitoring process.

It incorporates comments provided on the relevant discussion paper, distributed late last year, and identifies several areas needing additional input.

In partnership with employers and employees, workers' compensation insurers in the Northern Territory can play a pivotal role in reducing the social and economic cost of work-related injury and disease.

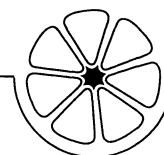
