

## Domestic Violence Regulations: new amendment

The following amendment to the Domestic Violence Regulations began on April 12, 1995.

"1. New Regulation

The Domestic Violence Regulations are amended by inserting, after Regulation 3, the following:

*"An application under the Act may be served on the defendant personally or by leaving a copy for the defendant at his or her last or most usual place of abode or of business with some other person who is apparently an inmate or employed at the age of 16 years."*

2. Declaration of Service of Summons or Orders

Regulation 4 of the Domestic Violence Regulations is amended by omitting "document" and substituting "summons or order".

The amendment is in accordance with the mode of service previously existing under Section 27 of the Justices Act."

## WHATEVER HAPPENED TO ...?

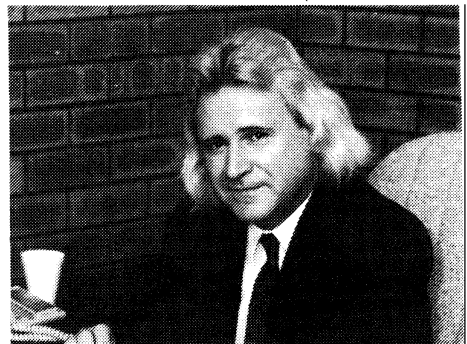
