

# BANKRUPTCY STATISTICS FOR MARCH QUARTER

Federal Justice Minister Duncan Kerr has released provisional bankruptcy statistics for the January to March quarter of 1995. These statistics show an overall increase of 3.1 per cent in administrations under the Bankruptcy Act (comprising Bankruptcies, Deeds of Arrangement and Assignment and Compositions) for this quarter over the same period in 1994.
