Crimes (Victims Assistance) Act - Application to Proceed out of Time - Jurisdiction Local Court Act

Cambridge Gulf Exploration NL
v Roberts and Ors

Judgment of Thomas J, delivered 8
December 1995

The appellant, pursuant to s 19(3) of the Local Court Act, sought leave to appeal from the decision of the Local Court granting the first respondents an extension of time within which to make an application for a Crimes (Victims Assistance) Act ('the Act') certificate.

The first respondent, in each of the four matters the subject of the appeal, filed an application on 16 January 1995 for an extension of time within which the bring an application for assistance pursuant to s 5 of the Act.

The Act enables a 'victim' of crime to obtain financial assistance. Section 5

permits a 'victim' to 'within 12 months after the date of the offence to apply to a court for an assistance certificate in respect of the injuries suffered by him as a result of that offence'.

Section 5(3) permits the Court to extend the period within which an application can be made. In this case the offence, which involved carrying out work on a sacred site contrary to s 34 of the *Aboriginal Sacred Sites Act* (NT), occurred in August 1993 and the application for assistance was made in January 1995.

The basis of the appeal was that the learned Stipendiary Magistrate had no jurisdiction to hear the application on the grounds that:

(1) the 'injury' alleged arose from 'the loss of or damage to property (which loss or damage is the result of an offence relating to that property);' which is specifically excluded in the definition of injury under s 4 of the Act;

(2) there was no evidence that the applicants had suffered 'mental injury'

which constituted a 'recognisable psychiatric illness':

(3) the precis of the facts showed that the applicants alleged 'mental injury and distress' which was caused by or arose out of the use of a motor vehicle 'namely a front end loader' and '... injury or death caused by, or arising out of, the use of a motor vehicle, except where that use constitutes an offence under the Criminal Code' is precluded by s 12(e) of the Act.

Held, that it was not incumbent upon the learned Stipendiary Magistrate to finally determine the substantive jurisdictional issues at the interlocutory stage. The learned Stipendiary Magistrate did not apply a wrong principle of law by referring to whether or not there was a case to be argued.
