## Tribunal Publications

*The following advice was received from the NNTT regarding arrangements for their Darwin Office.*

"I refer to previous correspondence in relation to the establishment of the Tribunal's office in Darwin on a six month pilot basis. The Tribunal has decided to extend the pilot programme for a further six months, to 31 May 1997, at which time the Tribunal will again review the feasibility of maintaining an office in Darwin.

Ms Andrea McCallum is now the Regional Co-ordinator for the Northern Territory, but is returning to the Tribunal's Principle Registry in Perth at the end of November to carry out other aspects of her duties.

From 2 December 1996, the Darwin office will be staffed by Ms Bu Wilson, Senior Case Manager, and Mr Mark Price, Case Manager's Assistant. All Northern Territory applications will henceforth be managed from the Darwin office. It is to be hoped this will facilitate improved local contact with the Tribunal for parties to applications and key stakeholders.

The NNTT has recently released a number of publications which may be of interest to practitioners.

Their 1995/96 Annual Report contains details of the Tribunal's activities during the period of report, including reports on community liaison, education and participation, creative and flexible resolution, cultural concerns and corporate services. The appendices to the report contain a mediation summary, a section on the historical context of accepted native title determination applications and a directory to the corporate structure of the Tribunal.

In his report, the President of the National Native Title Tribunal, Justice R S French refers to the many and complex issues and processes surround the work of the Tribunal and says: "*The work of the Tribunal since its establishment on 1 January 1994 has taken place in a complex, difficult and changing political and legal environment. Consistent with the requirements of the Act its objective has been to facilitate the recognition of native title and to promote just agreements about native title and the use of indigenous lands and waters. It seeks to do so in ways that are fair, just, economical and prompt and to take into account the cultural and customary concerns of indigenous people and the interest of all others affected by native title issues. In doing so it has the objective of promoting informed discourse between indigenous and non-indigenous Australians.*"

Copies of the Annual Report are available from the Tribunal at a cost of \$12 which includes postage and handling, or across the counter at the Tribunal's Registries at a cost of \$5. In addition the Tribunal is in the process of putting up a range of documents, including the Annual Report onto the Internet at its address 'http://www.nntt.gov.au'.
