#### 1995 Grant Burge Riesling

A pronounced spicy Riesling character on the bouquet. The palate is full of flavour.

#### 1995 Grant Burge Semillon

### 1995 Sauvignon Blanc

A fuller style Sauvignon Blanc.

## An Accessible Law Week for 1996

Following a meeting at the Law Society, plans for Law Week 1996 (to be held 13 - 18 May) indicate that this year's activities will deliver an informative and interesting package to the public. In addition, it is hoped that this Law Week will give local practices the opportunity to promote the profession better than ever before.

The theme for Law Week 1996 will be "Access to Justice", a concept which is sufficently broad so as to include all areas of the profession and to offer plenty of appeal to the general public.

As ever, the success of Law Week depends on the participation of all areas of the legal fraternity and it is to be hoped that members will be supportive of their Law Society in this endeavour.

Law Line, despite its popularity with the public, will not be run in 1996 as the service it has provided in the past is now available through the Northern Territory Legal Aid Commission's 1800 telephone line and the Darwin Community Legal Service's advice sessions. Instead, local radio stations will be asked to offer small segments where practitioners may be interviewed on air or even take a daily ride on Hot 100's Black Thunder!

It is hoped that the Law Walks, which were well patronised in the past, will be offered again in 1996 and the public libraries have been asked to act as a venue for public viewing of law-related videos.

New in this year's line-up is the intended "Breakfast in the Mall", where it is planned to launch Law Week. Practitioners may find themselves approached to take part in some unusual activities in relation to this in an attempt to show the human face of the law to the public!

Plans are underway for a mediation demonstration session and a Red Cross breakfast seminar.

The week's activities will culminate in the annual Law Week luncheon, and the Law Society is working towards offering something special this year, including Richard Ackland, current columnist in the Financial Review and the Justinian as speaker.
