## NT University Prize Winners

President Terry Gardner presented prizes to law students at the NTU's Faculty of Law Presentation of Prizes evening on Tuesday 30 April at the Supreme Court.

Guests included the Administrator, the Acting Attorney-General the Hon Daryl Manzle MLA, the Chief Justice of the Supreme Court, the Chancellor and Vice-Chancellor of the NTU.

Dean Elect of the Faculty, Jenny Blokland welcomed those in attendance and spoke of the achievements of the students and the future direction of the Faculty.

### Supreme Court Medal

The Supreme Court Medal, awarded to the member of the graduating class who has demonstrated outstanding professional promise through scholarship, character and leadership was presented

by the Hon BF Martin, Chief Justice. Its recipient, Richard Guit, has won a number of prizes during his law studies and received second place in the Paper Presentation Competition at the Australasian Law Students' Association Conference in 1995. Richard is currently employed as Associate to Justice Angel.

### Attorney-General's Medal

The Acting Attorney-General presented the Attorney-General's medal to Mathew Storey, who was declared the most outstanding graduand in the preceding academic year. Mathew, currently completing a legal cadetship with the Commonwealth Attorney-General's Department, achieved exceptional academic results and was the recipient of many prizes during the course of his degree.

### Free legal advice on copyright

The Australian Copyright Council was formed in 1968 with the aim of raising consciousness in all sectors on copyright matters.

Its objectives are to help copyright holders exercise their rights, to raise awareness in the community on the importance of copyright, to identify and seek changes to areas where copyright law is inadequate and to foster cooperation amongst bodies representing copyright holders.

To this end, the Council employs four lawyers who carry out a range of activities including research, seminars, consultancy and lobbying in the copyright arena.

They offer a number of bulletins and pamphlets which provide information in this area which affects a wide range of people in the community.

The Australian Copyright Council offers a free legal advice service by telephone from Monday to Thursday 9am-12pm and 2pm - 5pm on 02 318 1788.

### Business Law Fellowship

The Business Law Section of the Law Council of Australia has announced the establishment of a Business Law Fellowship designed to promote and develop further education of Australian lawyers.

It is intended to enhance technical skills, promote research and the study of business law with a view to improvement of law throughout the Commonwealth and to advance legal scholarship generally.
