NT Attorney-General's Department announces that the Criminal Code Ammendment Bill (No 6) and the Criminal Code Ammendment Bill (No 5), each of which were passed during the February 1996 sittings of the Legislative Assembly were assented to by the Administrator on 10 April 1996 and are now known as the the Criminal Code Amendment Act (No 2) 1996 - No. 11 of 1996 and the Criminal Code Amendment Act (No 3) 1996 - No. 12 of 1996 respectively.

Notice of Commencement appeared in Gazette G20 15 May 1996 and each Act commenced on 20 May 1996.

# **Take note:** Eurotext Scam

Ian Dunn, Executive Director of the Law Institute of Victoria warns of a scam being perpetrated by a company known as Eurotext International who claim to run an international business register.

Firms in Darwin have been approached from England and the local "representative" has been calling on local practitioners over the past few weeks. The matter has been reported to the police who are making enquiries into the scheme.

The company has been calling solicitors throughout the country with the stated aim of recruiting firms to whom work relating to relocating of businesses to Australia from overseas would be referred. They ask for an up-front fee of \$4,700 and at a meeting, press the targeted firms for an immediate decision and payment, citing a need to advise other competing firms of the outcome.

According to advice from the LIV, the Melbourne Fraud Squad is satisfied that it is a scam and have suggested that the LIV warn interstate Law Societies. Engineers, architects and accountants have also been approached by Eurotext International.

### Claims against QBE
