# Bank Cheques

Chief Manager of Westpac Bank's Client Relationship section, Vernon Kelly, advises that recent system and procedure changes have enabled Westpac and Challenge Bank branches to issue automated bank cheques through their branch computer systems.

The computer-issued bank cheques retain similar layout, colour scheme and security features as non-computer-issued bank cheques, but carry only one signature. These cheques comply with all requirements of the *Cheques and Payment Orders Act* (1986).

Dual signature cheques will continue to be used for some time to come, but many Westpac and Challenge Bank cheques used in everyday situations, including conveyancing, will be of the single signature type.

Westpac Bank had noted that some members of the legal community had expressed reservation about accepting the single signature cheques, seeing the practice as a departure from the traditional.

Westpac requests that members of the Society are advised of this change in procedure in order to allay uncertainty about the validity of single signature cheques.
