#### 1. COMMERCIAL LAW

This disk has the Bankruptcy and Insolvency Library which contains McQuade - *Bankruptcy Guidebook*; McDonald, Henry and Meek - *Bankruptcy Law and Practice*; O'Donovan - *Company Receivers and Administrators*; bankruptcy and insolvency cases; and bankruptcy and insolvency titles from *The Laws of Australia*, *Australian Digest* and *Australian Legal Monthly Digest*.

#### 2. COMPLETE LEGAL RESEARCH SYSTEM

The complete Legal research System on CD-ROM and contains *The Laws of Australia*, *Australian Digest*, *Australian Legal Monthly Digest* and *Australian Case Citor*.

#### 3. CURRENT JUDGMENTS

It contains the latest reported and unreported judgments in full text from the High Court, the Federal Court, the Industrial Relations Court of Australia, State Supreme Courts and selected other jurisdictions. Once the case becomes reported, the summary note will be replaced with a formal headnote and a typeset judgment.

#### 4. FEDERAL CASES

This is a two disk service containing *Commonwealth Law Reports*, *Federal Court Reports*, a *Federal Court Citor* and unreported decisions from the High Court, Federal Court and the Industrial Relations Court.

## CIJL

The Centre for the Independence of Judges and Lawyers (CIJL) is an organisation dedicated to the promotion and protection of the independence of the judiciary and the legal profession world-wide.

As part of its effort to achieve its objectives, the CIJL publishes a yearly edition of *Attacks on Justice: The Harassment and Persecution of Judges and Lawyers*.

This publication analyses the relationship between government and the judiciary and legal profession in as many countries as possible and cites specific cases of harassment of judges and lawyers.

Current practice is to present *Attacks on Justice* to the governments of those countries included in the publication in draft form for comment, and to include those comments in the published edition.

The CIJL is now requesting information on harassment and persecution for inclusion in its 1997 edition of *Attacks on Justice*. "Harassment" may include anything from new legislation which, for instance, restricts the judiciary's right to determine its own jurisdiction, to physical and verbal threats against a lawyer who is representing an unpopular client.
