## Work Health

The Work Health Authority recently forwarded to the Society a copy of a report prepared by Transformation Management Services on the review of the workers' compensation dispute resolution processes that operate under the Work Health scheme in the Northern Territory.

The terms of reference were to:

1. Identify and document the current procedural requirements and actual practices relating to the hand ling and resolution of disputes:
2. Draw from existing documentation on best practices in the field of work

health dispute resolution, and identify opportunities for the adoption and implementation of appropriate changes that capture or improve on these best practices.
3. Examine and document the potential costs and benefits of possible changes to practices, regulations, rules or legislation. It is expected that the review would need to obtain a clear understanding of current costs, to support the identification of potential savings.
4. Make recommendations for changes that clearly indicate the expected improvements in terms of economy, efficiency, effectiveness or outcomes.
5. Identify any risks involved in the adoption and implementation of proposed changes and make recommendations for how these risks might be appropriately managed.
6. Provide advice on an appropriate system of performance measurement for monitoring the economy, efficiency and effectiveness of dispute resolution processes.
The Work Health Authority intends to run a public seminar to discuss the report's findings and a bulletin will be issued when details of the time place and venue are received.
