

# Psychological Reports

The President of the Association of Private Practising Psychologists, Ms Maria De Ionno has noted that there is some concern amongst legal practitioners regarding the cost of psychological reports.

In the interests of developing a better understanding between the professions, Ms De Ionno has offered to meet with members of the Law Society to explain the type of tests and other assessments, interpretation and integration of information and procedures involved in preparing psychological reports for court and other purposes.

## Federal Costs Advisory Committee

**The Secretariat of the Law Council reports an excellent result from the Federal Costs Advisory Committee fourteenth inquiry.**

The LCA, represented at the inquiry by Michael Harmer, submitted that federal court scales should be increased by 4.54% – an amount derived from calculation of indices based on the weighting of components adjusted to reflect information on the cost structure of legal firms noted in the Australian Bureau of Statistics report Legal & Accounting Services 1995-1996. The Commonwealth submitted that an increase of only 2.4% was warranted.

The FCAC has concluded that it will recommend to federal courts that they increase the scales of solicitors' by an amount of 4.5% and has sent copies of the report to the Chief Justices of the High Court, family Court and Federal Court for their consideration.
