# Listing of Matters in January 1999

As in the past years, the Court will make available such number of Judges as may be required on adequate notice, to undertake normal work during the month of January 1999. The concept of having a single "duty' Judge available to attend to urgent matters is no longer the case.

Any party seeking to have any matter listed for hearing during the month of January 1999 should apply to do so prior to the end of September of this year. Applications for listings after that time will be entertained at the discretion of the Chief Justice, dependant upon, inter alia, the Judge time available. If one party seeks to have a matter listed for hearing during that period and the other is unwilling, a decision will be made by a Judge in light of all the circumstances.

This procedure will apply to all jurisdictions of the Court in Alice Springs as well as Darwin.
