Ned Kelly at the Hard Rock Hotel

Sir Redmond Barry's attitude was very plain. As the Herald had reported two weeks before. "The trial of Ned Kelly will be disposed of as soon as possible, arrangements having been made for lighting the court with gas after dusk." On the day of the trial the Herald claimed that Barry was willing to sit on till midnight. He was keen to wrap up the wretched business in a single day's sitting.

Sixteen witnesses were called. The most embarrassing to the prosecution being Jerilderie Bank Manager, John Tarleton. He quoted Ned as saying; 'It is all very well to say that we shot the police in cold blood. We had to do it in self defence."

Unfortunately his Honour was unable to finish the trial that day. At 6.05pm Barry asked the prosecutor, Smyth, if the case could be completed that night. He was told that there were eight more witnesses to give evidence. Reluctantly Barry adjourned the case to 9.00am the following morning. Case management is obviously not a modern phenomenon.

In his rambling charge to the jury Barry, with true judicial rectitude (of the time naturally), removed a very sound defence of self defence from the jury. He told the hanging dozen that the police party "had a double protection: that of the ordinary citizen and that of being ministers of the law charged with the administration of the country." The fact that they were shooting at Kelly before he raised his weapon was neither here nor there. Barry fulminated, "What right had four other armed men to stop them and ask them to surrender, to put up their hands? I repeat, they were executive officers of the law and no person had any right to stop them or question them". I mean, who was this character Barry? What was Kelly to do with a bunch of mad, glory hunting incompetent coppers who were trying to shoot him? Yell out, "Hold on blokes, you look a little crazy. Why don't we sit down and talk this over while we boil the billy?"

At 5.10pm the jury retired. Their deliberations were obviously embroidered with a determination to arrive at the right decision for they returned after only half an hour. Funny you don't ever hear of people nowadays saying "You know I'm related to a member of the jury that convicted Ned Kelly" But you often see claims made by people that they are related to some character who was held up by Ned Kelly.

The newspaper, the Telegraph, is regarded as providing the most accurate account of what took place as Kelly journeyed to the scaffold:

"On leaving the cell, and before stepping upon the drop, an expression, with a sigh, escaped Kelly's lips, which the warders and the Governor interpreted to this effect - "Ah well, I suppose" - probably meaning to say he supposed this was the last of it, or this is what it had come to, but the expression was never concluded".

The Yarralin Aboriginal people of north-western Australia have taken Ned into their dreaming. They tell the stories of his exploits. The Aborigines affirm that Captain Cook is long dead while Ned Kelly - because he is concerned with freedom, dignity and justice - lives on.

When you read "Ned Kelly A Short Life" by Ian Jones(from which most of the above potted history was plagiarised) you get the idea that Ned was the sort of bloke who would
