

Australian Lawyers stand up well to Examination

Australian Lawyers represented by far the largest nationality of foreign lawyers to have taken and passed the Qualified Lawyers Transfer Test (QLTT) in England, according to the Law Society's Gazette. What's more, they have a pretty good pass rate - 76 per cent of the 1,050 who have taken the test since 1991 (In a recent sitting, 46 out of 48 Australians passed).

While fewer of them take the QLTT, New Zealand lawyers have a higher pass rate, 80 per cent, but only 61 per cent of US Lawyers have managed to pass the test.
