President's Report 1998/1999 Annual General Meeting

1998-99 has been a busy and productive year for NTWLA. We are now an incorporated association. The focus of our energies has been on providing opportunities for professional development and in taking community action by making submissions on legal policy issues. Our current financial membership is 48 but the level of interest in our activities indicates a much wider support of our objectives. Membership in Alice Springs is low, a priority matter for the Association in the coming year.

NTWLA publishes an article each month in *Balance*, the NT Law Society magazine. This allows the Association to put matters of importance and interest into the public domain, and assists us to inform members on contemporary thinking around legal issues. Additionally we have circulated some bulletins throughout the year to members. I would like to thank the NT Law Society for their support by providing space for Association comment.

Community / Public Affairs

Trials Through Time for Law Week was a repeat of last year's event. The format of women lawyers reading excerpts of famous (and infamous) trials through history was a great success and we plan to perform again for LawWeek 2000.

NTWLA was one of the co-sponsors of the Community Forum on Domestic Violence and the Law entitled "Who are you listening to?" This forum provided an opportunity for a range of people who work in the area of domestic violence to update their knowledge and network with other practitioners.

NTWLA members visited three high schools and talked to senior students. The theme of the talks was Equal Opportunity, and teachers took the opportunity to have us speak on legal-related topics as well.

Policy /Law Reform

We have been encouraging members to take an interest in Reconciliation and to

that end NTWLA is co-hosting, with Lawyers for Reconciliation, a meeting on the Draft Document of Reconciliation. While this is a national issue, there is no doubt that the NT has a very special part to play in the reconciliation process. We plan to prepare a response to the draft document.

Last year the association resolved to oppose mandatory sentencing. Throughout the year we continued to advocate for change. NTWLA was one of sponsors of an advertisement detailing the costs of mandatory sentencing to the Territory.

NTWLA made a submission to the Office of the Anti-Discrimination Commissioner inquiry into 'The Provision of Interpreter Services in Aboriginal Languages by the Northern Territory Government'. The submission supported the need for interpreting services and referred the Commissioner to the rules governing legal practice and in particular the importance of acting on instructions.

NTWLA continues to be involved by publicising the issue and by our representation on the NT Law Society Sub-Committee making recommendations on standards for practitioners.

Following a report that women prisoners deemed 'at risk' were held in the remand section of the prison at Darwin (a male only section), NTLWA wrote to the Minister of Correctional Services and the Chief Minister and the committee plans to continue making representations on the issue.

Professional issues

The Committee is working towards a dedication ceremony for the Jane Mahony Memorial section of the NT Supreme Court Library. Jane was well respected throughout the profession and the Memorial will provide legal resources for all in the profession.

In October 1998 a Mentoring programme was launched with 11 pairs of mentors and mentees - this was a joint initiative with Young Lawyers. An evaluation of the program will be actioned.

For the Opening of the Legal Year Alex Richards QC, President of Australian Women Lawyers, spoke in both Darwin and Alice Springs. Alex attended a dinner in Alice Springs and a breakfast in Darwin. The AWL Board meeting was also held in Darwin at that time and this was a great opportunity for members to meet the Board both formally and informally.

Justice Sally Thomas, patron of NTWLA, hosted drinks on the Judges Balcony of the Supreme Court on 19 March. The evening was an outstanding success for everyone and we plan to hold another reception next year.

I would like to thank our Patron for her support and encouragement throughout the year.

A survey of the legal profession on work practices was proposed but a lack of appropriate resources has stopped the project from getting off the drawing board. The credibility of the survey will be severely undermined unless it is completed to a professional standard. It remains on the agenda.

A seminar on negotiating salary packaging was held in March in the Clayton Utz Board Room. Many of the younger members attended this well structured seminar.

Maria Ceresa, Executive Officer of the Law Society of the NT, spoke at a lunch hosted by the Association. Her topic 'Image of Lawyers' was both amusing and thought provoking. There is strong support for more such events and the Committee plan more social events in 1999/2000.
