ASU Award for private sector lawyers

The Australian Services Union (ASU) is the principle white collar union in the local government sector, the social and community services sector and in the private sector throughout Australia.

The ASU has succeeded in establishing minimum conditions of employment Awards of the Industrial Relations Commission for Victorian and South Australian private sector salaried lawyers and professional legal officers.

The ASU also seeks to create an Award of the Australian Industrial Relations Commission for Northern Territory private sector articulated clerks, salaried lawyers and professional legal officers in the year 2000. At present there are no legally enforceable minimum Award conditions of employment in Northern Territory for private sector articulated clerks, salaried lawyers and professional legal officers regulating wages, hours of work, redundancy pay, sick leave, overtime and lunch breaks, just to name a few.
