
Freedom of Information

We propose writing to the Attorney General and will seek the opportunity of presenting the case for Freedom of


Information in the Northern Territory.

Throughout the mandatory sentencing debate NTWLA has opposed the operation of a system which has taken the discretion from the court in the sentencing process. Recent events have taken the focus from mandatory sentencing. The 12 month "third strike" sentences of imprisonment are starting to become more common. The community must consider whether the cost - both economically and socially of a scheme which so often sees an offence leading to a disproportionately
