A practising lawyer of 24 years experience with a reputation of an excellent and highly experienced advocate, Ms Cox says she intends to keep going to court.

"This-is quite a challenge and it's good to be confirmed in the position because it means now we can properly start looking at ways to improve what do date has been one of the most successful commissions in Australia," she said.

Celebrating the ICC

On Tuesday 2 July the NT Division of the Australian Red Cross celebrated the birth of the unprecedented International Criminal Court by hosting a Mock Trial at the Supreme Court of the Northern Territory.

The Mock Trial considered the indictment of Captain Rogue for an armed attack on both civilians and aid workers in an Internally Displaced Person Camp in the State of Governia. Outstanding performances and persuasive arguments were mounted by both the defence team (Jenny Blokland, LCDR Richard Crane, Koula Saroglou) and the prosecution team (Tom Pauling QC, Kai Li Tan, Belinda Williams).

The panel of three judges (Hon Austin Asche, Hon Justice Sally Thomas and Hon Justice John Gallop) found Captain Rogue guilty on two counts of committing a war crime, namely

murder and attacking an object and person displaying the distinctive Red Cross emblem, but he was found not guilty of committing a crime against humanity. The judges reserved their decision on sentencing.

The captivated audience was dazzled by the performance of participants such as Jamie Gallacher (the War Correspondent), Rowan Charrington (the International Committee of the Red Cross Representative), Mariella Nicolosi, who passionately portrayed the Internally Displaced Person Witness and Tom Berkley who effectively played the "baddie" Captain Rogue! All-in-all a fascinating night. ①

"I think we give hope to people who felt there was nowhere for them to turn before because all their other legal avenues had been exhausted. We're a body that can at least investigate the claims and hopefully rectify some of the wrongful imprisonments," she said.

Lynne was recently in Darwin and spoke to practitioners about the Project.
