

Law Week news

April and May have been another busy couple of months in the Territory both for the Law Society and the legal profession. The Dry season has definitely started and with it the social calendar of people in the Top End is filling up.

The Law Society's pro bono and legal aid committee and the Legal Aid Commission organised the Pro Bono and NT Legal Aid Service Providers conference which was held in Darwin in early May. The conference was funded by the Law Society Public Purposes Trust and included representatives from all over the Territory and major interstate law firms. (A full report is on page 26.)

Since my last report, the Society has been busy with Law Week 2005. Law Week ran from Sunday 22 May until Sunday 29 May and featured the traditional lunches in Darwin and Alice Springs, the Tugof-War competition, the cricket challenge and a range of community activities. I was the prosecutor in the mock trial of the Three Little Pigs, which was held as part of the Supreme Court Open Day. I would especially like to thank Justice Southwood, Peter Barr QC, Duncan McConnel, Jo Tomlinson, Gavin Heatherington-Tait and Sara Smart who rose to the occasion on short notice.

I officially launched Law Week in the Mall on Monday 23 May with the Tug-of-War competition. Many were relieved to see the reign of Karczewski's Killers at the DPP end when they were defeated in the grand final by the School-based Constables from the NT police.

I travelled to Alice Springs for the Law Week lunch with guest speaker Stephen Mayne. The founder of the independent media e-zine crikey.com.au, Stephen entertained us with his encounters with defamation law. (A copy of the speech is on page 11).

The Darwin lunch returned to Parliament House this year and despite the bigger venue the lunch still sold out. During the Law Week lunch, the winners of the Law Society Community Contribution Award were announced. Justice Sally Thomas, Daryl Manzie and myself made up the judging panel for this year's award.
