On-Line CPD Trial

Law Society in 'he conjunction with Charles Darwin University held a trial for delivery of CPD's on-line on the 19th May 2009. The session was quite successful with participants from Alice Springs, Katherine, Tennant Creek and Darwin attending. Zoe Marcham. Actina Commissioner of Information gave a presentation on Federal Freedom of Information and Privacy Act.

The benefit of this method of delivery is that there is no delay with hearing the material unlike video conferencing where there is a 5 - 10 second delay. A question can be asked at any time unlike DVD and the session is in real time. There is an opportunity to text a question to the main room or to an individual participant which is a great backup if in the event of any problem with audio. Less paper is used as the power presentation is on your screen. There will always be times when it is not physically possible to be on-line or attend a CPD due to other commitments, however this delivery method gives those practitioners an opportunity to hear presenters in Darwin and interact with colleagues from different parts of the Territory.
