Australian Young Lawyers report

On 26 February 2010, Co-President of NTYL, Nick Johansen, attended the AYLC meeting in Brisbane. Representatives of the young lawyer groups from every State and Territory were also in attendance.

The meeting was primarily focused on strategic planning for 2010 and a number of policy directives were initiated. These included, in relation to the issue of recruitment and retention of young lawyers (being lawyers in their first five years of practise but of any age), the commissioning of a survey to be undertaken by young lawyers in order to gather and disseminate information regarding issues such as job satisfaction and the progression from studying law to practising law.

Also, a working group was created to develop AYLC policy approaches toward the recently introduced statement by the Law Council of Australia on Indigenous Australians and the Legal Profession and the proposed "Reconciliation Action Plan".

Nick also raised issues that are presently being implemented by the NTYL here in the Territory including the potential commencement of our own indigenous mentoring program in which we hope to promote the aims of the national Reconciliation Action Plan at a Territory level.
