First Young Lawyer CPD

NTYL have been busy organising the first ever Young Lawyer CPD. This development forms part of the dual NTYL's commitments for 2010, those being to play an increasing role in the supporting of young lawyers around the Territory and to actively participate in the retention of young lawyers in the legal profession.

The CPD, with a working title of 'Depression and Anxiety in the Legal Profession', will be aimed at assisting young lawyers to cope with early years in practice. NTYL has approached Mr. Jason Schoolmeester and the group Relationships Australia to present at the CPD, which is scheduled to be held in early July.
