The Pro Bono Clearing House Wants You. Yes You!

he Law Society Northern Territory runs a Pro Bono Clearing House (PBCH). Throughout the years the Society has run a fairly modest yet successful pro bono program. Pro bono work provides legal assistance for those who would otherwise be unable to obtain support.

The PBCH is made up of a pro bono panel and register. The panel consists of volunteers who assist in determining the eligibility of applicants.

Career transition and on-the-job training

> The PBCH register comprises of volunteers who, if available, assist with cases that are eligible for pro bono. Lawyers on the register have no obligation to take on a matter.

> The PBCH receives requests for assistance in all types of matters including Family, Immigration, Employment, Civil, Criminal etc. so it is vital to have Legal Practitioners with expertise in different areas of law.

In November clearing houses around Australia met in Adelaide for the National Pro Bono Conference. Of the many issues discussed, the capacity to assist people with immigration matters was prominent and at the forefront of discussion. The NT PBCH is particularly urging practitioners that may have experience within Migration Law to join the register.

The PBCH is continuing to grow each year.

In 2012 the PBCH had a total of 14 lawyers (2.5% of NT lawyers) on the register. Since then the PBCH register has increased to a total of 43 lawyers (7.8% of NT lawyers).

It is a goal of the PBCH to increase the register to 10% of lawyers by June 2015. This is an achievable goal and I would encourage all practitioners to join this rewarding program.

WHAT'S IN IT FOR YOU?

Pro Bono may be the provision of legal services to those unable to it afford it but there is something in it for you.

Pro bono is rewarding in so many ways, some of them unexpected. It reminds you of how lucky you are in these tough economic times. It gives you a sense of purpose to help those less fortunate than yourself and it helps you hone and develop your skills.
