It's that time of year again—with key regulatory obligations for legal practitioners in the Northern Territory falling due between April and June.

By now you should have submitted your Annual CPD Certificate, and if you didn't manage to accrue all the points in the required competencies you have until 30 June 2019 to make up any shortfall and submit a Supplementary CPD Certificate.

For all law practices the annual reporting period relating to trust monies has started. If you are unsure about what reporting obligations your law practice might have, check out the information available on the Society's website and keep an eye on *The Practitioner* e-newsletter for alerts and reminders about what is due and when.

The key obligation that affects all legal practitioners in the Northern Territory is the need to take steps to apply to renew your practising certificate for 2019/20. This year's renewal process will be significantly different for practitioners with the changes to the practising certificate application forms, including the introduction of a new renewal form, and the ability to submit your application as a PDF rather than posting or delivering an original form. The Society considers that these changes will bring benefits for practitioners in the long-term but appreciates that the during the transition period this year there may be impacts for some practitioners. The Secretariat is keen to work with practitioners to make the change as smooth as possible.



The Society is looking forward to the variety of events organised for this year's Law Week from Sunday 12 May to Sunday 19 May 2019. We thank the other organisations who support Law Week by offering a variety of activities to engage the community and help raise awareness about the law and the important role of legal institutions. Aside from the Society's annual Law Week lunch in Darwin and Law Week dinner in Alice Springs we see the return of the Law Week trivia night—will the Oxford Commas emerge victorious again or can another team claim the title? The Society is also very excited about the Tug of Law making its reappearance on the Law Week calendar of events after a considerable hiatus.

Work is under way to prepare for the impending visit of the Law Council of Australia; directors from across Australia will be travelling to Darwin for their June Directors' meeting.
