Law Week event:

Jane Mahoney Collection book launch

NTWLA celebrated the life of Jane Mahoney on Wednesday evening 15 May 2019 during Law Week with the introduction of a number of new books to the Jane Mahoney Memorial section of the Northern Territory Supreme Court Library.

The Jane Mahoney Memorial section was established by NTWLA in conjunction with the Supreme Court Library Committee. The books were purchased with funds from Jane's mother who left a bequest in her will to cover the cost of the books. There are still funds remaining so any suggestions for additional books are very welcome.

Jane and her husband Tony died tragically in a motor vehicle accident on the Cox Peninsula Road near Darwin on 12 July 1998. Many lawyers in our current legal profession remember Jane, in particular Ms Jenni Daniel-Yee, who gave a moving speech about Jane at the event. Ms Daniel-Yee spoke about working with Jane at the Solicitor for the Northern Territory (or, the Department of Law, as it was called back then). She said "[i]t was a privilege to work with someone like Jane and an honour to be speaking about her this afternoon. She was someone I had a lot of respect and affection for."

Ms Daniel-Yee told us about the Memorial tree that has been planted at Mandorah by the Wagait Beach Coastcare Group in memory of Jane and Tony. Jane lived in Mandorah and enjoyed the ferry ride across the harbour every day to get to work. Jane had a green thumb and did a lot of work transforming what she called "the sandpit" into a beautiful lush garden at her Mandorah house.

Jane was a respected member of the legal profession, who is remembered by her colleagues for both her personal qualities and her abilities as a lawyer. She was a gentle and unassuming person with a highly developed sense of personal and professional integrity. She is sorely missed by those who knew and loved her and it was a great loss to the Darwin legal fraternity and the small community of Mandorah when she passed.

All legal practitioners are welcome to borrow any of the books in the Jane Mahoney Collection (see list of books on page 10). Just drop in to the Supreme Court Library between 8:30 am and 4:30 pm Monday to Friday and ask the friendly librarians about the collection!

Kristy Bloomfield seminar on the **Rights of the Child**

On 21 May 2019, Alice Springs Women Lawyers were fortunate to host a presentation by NAAJA Law and Justice Officer Kristy Bloomfield. Kristy travelled to the United Nations in Geneva, Switzerland in April 2019 to present at the pre-sessional working group for the Committee on the Rights of the Child. Submissions made to the pre-sessional working group inform the committee's review of the implementation of the Convention on the Rights of Child by state parties. The process is confidential, but Kristy was able to share the statement which she made on behalf of NAAJA. This statement touched on the experience of NT children in youth justice and child protection systems with a particular focus on the experiences of Aboriginal children.

We are very grateful to Kristy for giving us her time and sharing this experience with us. It was wonderful to hear about Central Australia being represented on the global stage and we look forward to running more events showcasing the great work being done by women in the law in the Centre.
