Audiovisual materials

The AIATSIS Audiovisual Archive holds a sizeable collection of 78 rpm discs containing early recordings of Aboriginal music and speech, some dating from the 1930s. These can be found on AIATSIS' on-line catalogue, MURA, by searching on PR_00, which is part of the matrix numbers. These include recordings made by A.P.Elkin, early radio discs, and some of the *Buenas Nuevas* recordings, which are Bible stories told in Anindilyaugwa, Nunggubuyu, Larrakia, Batjamal, Wogait and Malak Malak recorded in the 1950s.
