

## ELECTRIC SHOCK ACCIDENT

We act for a man who suffered an electric shock at work in 1996. Since that time he has complained of a constellation of symptoms including blurred and double vision, loss of hearing, tinnitus, loss of concentration and memory, headaches, chest pain, shrunken and sore testicles, impotence, disturbance of pain in all limbs, swelling in the legs, tremors in the body, depressed moods and suicidal ideation.

We have reports from more than 20 doctors in different specialities who have been treating him.

Is anyone aware of a doctor with expertise in doing an overall assessment of electric shock victims? We need a doctor who is able to bring together all of the various symptoms to a firm diagnosis and attribute them to the electric shock.

## SKATE RAMP ACCIDENT

We act for a thirteen-year-old child who suffered a closed head injury when he attempted to jump from a skate ramp at a local park on his push bike. The ramp incline and decline were semi-circular with a 1 metre wide platform section in the centre. The ramp platform was elevated approximately 1.5 metres. A smaller version with a central platform of 0.75m elevation was co-joined. Our client suffered injury as he jumped the large ramp but landed head first on the smaller ramp. We are aware of approximately 6 other children who have recently injured themselves on the ramps. Would any member who has experience with such a case or who is aware of an expert who could report and give evidence on design, safety and layout contact me.
