### ACT Group

The UCLS ACT Group organised a seminar or 'Middle Management' at University House, ANU, on 9-10 May. Participants were largely derived from libraries in the ACT region but interstate speakers and participants included Neil Radford, University of Sydney Library and Eric Wainwright, University of Queensland Library.

The seminar was addressed by speakers from the Public Service Board, the Canberra College School of Administrative Services, the ANU Administration, the ANU Library and the Canberra TAFE. Topics discussed included 'Is participatory management possible' and 'Sexism and discrimination in libraries'. It is intended to hold specific follow up seminars in the light of feedback received at the sessions.

## VIC CHILDREN'S LIBRARIES

ON May 3 a stimulating one-day workshop on 'Education for children's librarianship' was held at Carringbush Library. Forty participants from public libraries, school libraries and tertiary teaching institutions met to discuss subjects of vital concern to all involved in children's librarianship.

The major areas of discussion were formal courses, in-service training and continuing education. There is concern at the lack of development in each of these areas so far as specialisation is concerned, and the workshop was convened to clarify needs and suggest possible solutions.

The meeting delegated the Executive of the Children's Libraries Section, Vic Group to follow up the resolutions passed at the meeting, and in particular to convey the ideas expressed to the LAA's Board of Education, library schools and other bodies. The Group recommend such a gathering to other states as an extremely valuable experience.

## From the Board of Education

The Board of Education met in Sydney on 17 and 18 April 1980.

It considered a paper prepared jointly by Mrs Margaret Trask and Associate Professor Carmel Maguire on the LAA's role in education for the library profession and other information specialists.

The paper suggested the desirability of a complete revision of existing statements of policy in education-related matters, including the criteria for the recognition of professional courses and courses for library technicians.

It saw the need for these changes to be based on up-to-date Association policy formulated in the context of a society which has changed and is constantly changing, with consequent shifts in information needs and in opportunities for information provision.

The authors presented, as the foundation for the suggested new statements and course recognition criteria, a draft 'Statement on the roles of librarians and library technicians: a guide for employing authorities and trade unions'. This draft will now be further refined and it is expected that a final version will be approved by the Board at its next meeting and recommended to General Council for adoption. Sub-committees of the Board were appointed to prepare statements which would revise the criteria for recognition of courses, and the Board intends to invite the schools of librarianship to comment on the drafts later in the year.

The Board resolved to recommend to General Council that the Library Technician Certificate course conducted by the Department of Education, Queensland, be recognised until the end of 1982, recognition to be retrospective to the commencement of the course in 1976.

Visiting panels were appointed in connection with assessment for recognition of re-recognition of courses in the following institutions: Ballarat CAE, Hartley CAE, Melbourne State College, Monash University, Royal Melbourne Institute of Technology, and the University of New South Wales.

At the request of the Executive Committee the Board considered whether it would be feasible and desirable for the Association to charge institutions for all or part of the costs incurred in course recognition activities. As a first step the Board asked the Executive

Director to ascertain the practices of other professional bodies in Australia which assess and accredit tertiary courses in their discipline.

The Board considered a draft of a procedure manual for course recognition visits and associated activities, prepared by the Convener of its Course Recognition Committee.

The Convener of the Continuing Education Committee reported on developments so far this year. It is proposed to mount a second round of travelling workshops on AACR II, and a course presented with particular emphasis on the needs of school librarians is under discussion with State Education Departments and ASLA.

The Board decided to support in principle the mounting of a travelling program on middle-level library management and the holding of a national seminar on school libraries and networks. Library schools will be invited to tender for the preparation of the former, and the latter will be referred to the School Libraries Section for action.

The Committee will report to the next meeting on the feasibility of bringing a distinguished young adult librarian to Australia to conduct courses.

It was resolved to refer to the Branches the Audiovisual Services Committee's proposal for a travelling seminar on micrographics, to see whether members would be interested.

The Board noted that General Council at its last meeting had elected Mr E. Parr and Mrs C. Pivec to membership in place of Dr N. Radford and Assoc Prof C. Maguire, whose terms had expired.

Mr E. Flowers was elected Chairman of the Board to fill the remainder of Dr Radford's term of office, and Mr J. Brudenall was elected to replace Mr Flowers as Convener of the Course Recognition Committee.
