## VICTORIAN BRANCH

### Library services for the handicapped

The major issue at that meeting was the demand from handicapped users representatives to have representation on the National Library Committee. ### Non-English language materials cataloguing pilot scheme

FOR some time now Victoria's teacher-librarians have been concerned at the lack of clear, workable, uniform standards in relation to the cataloguing of non-English language materials.

With the support of a special grant, the Section is hoping to remedy this situation by conducting a series of seminar-workshops in city and country venues aimed at the resolution of common problems. It is hoped that a manual of standard practices will be produced as a result of these meetings.

At this stage the section is seeking state-wide responses to these two questions:

How do you process, classify, catalogue and organise your non-English collection at present?

What are the major problems which need to be solved before large scale expansion of your non-English collection can be easily undertaken?

The most recent was on 29 May when Margaret Clinch (Assoc Head of the Learning Resources Centre at Darwin Community College) spoke of her experiences of North American library services during a year spent completing her MLS degree at the University of Western Ontario from 1978-1979. In a well illustrated and interesting talk Margaret spoke of the library scene in Canada and the USA including library services to North American Indians and visits to libraries in the West Indies and Hawaii.

Early this year Ron Davis, Director of the NT Library Service, gave a stimulating address to the NT Branch in which he outlined plans for the improvement and expansion of public and state type library services in the Territory.

Future plans include a General Meeting to launch a *Directory of Libraries*. This is to be held at a Darwin bookshop with the participation of local booksellers, librarians and others interested.

Other activities planned include a meeting at the Library of Darwin's Casuarina Public Hospital where librarian Joy King will be the host; a joint meeting with the Darwin (Migrant) Resource and Settlement Centre; the LAA's Government Publications Workshop; and a report on the Library Technicians Conference in Adelaide.
