Back to basics

APPROPRIATE technology — a hot topic in the community today — is the subject of a selective bibliography published in 1980 by the Department of Librarianship at Melpourne State College.

Pauline Cahir's Appropriate technology in Australia: a selective annotated bibliography is quite candidly a 'limited sampling of resources and projects' in this field, and is very much 'Melbourne-centred'. The compiler sees this publication as a beginning, with similar works being necessary in other Australian and New Zealand cities.

That may well happen, but meanwhile there is this 110-page work, covering 481 monographs, periodical articles and groups and organisations with an interest in solar, hydrogen, wind, water, biological energy, recycling, organic gardening and a host of other related topics. There are author, name, periodical title and subject indexes. It's a very useful basic guide, and excellent value at \$4.00 including postage.

Sticks and stones

AMNESTY INTERNATIONAL has been variously described as 'this espionage agency', 'this imperialist body' and as an 'instrument of communist terrorism'. Such contrasts emerge from *AI in quotes* (London, Amnesty International, 1976; ISBN 0 900058 277;50 cents), a compendium of brickbats and benedictions.

Among the many publications of this organisation, which is devoted to human rights around the world, are *Prisoners of conscience in the USSR*, 2nd ed. (Sydney: Amnesty International, 1980; ISBN 0 909382 33 6; \$5.95), *Indonesia* (London: Amnesty International, 1977; ISBN 0 900058 63 3; \$4.50) and *Political imprisonment in the Peoples Republic of China* (London: Amnesty International, 1978; ISBN 0 900058 80 3; \$3.50).

Another, regular, publication is *A chronicle* of current events, subtitled Journal of the Human Rights Movement in the USSR, a cover-to-cover translation of a clandestine journal produced in typescript and circulated like a chain letter in the Soviet Union. Amnesty International has issued the Englishlanguage version since 1971.

THE multiplicity of government department libraries in Great Britain and Northern Ireland is bewildering. Thanks to a British Library publication, now in its 24th edition, you can find the library you want, in the subject area you want, conveniently and quickly.

The 1980 Guide to government deparment and other libraries aims not only at comprehensive coverage of central government libraries but also includes details of libraries (such as the Australian Reference Library) attached to High Commissions and learned societies. Very full details are given for most entries and the work is excellently indexed.

AUSINTEL Activities

THE Australian International and Ethnic Library (AUSINTEL), which is part of the National Library of Australia, is now over a year old, and in its first year of life has produced a promising crop of bibliographical publications to make its collections better known to Australians at large. Among its publications are six area studies guides, major bibliographies of the NLA's holdings relating to Latvia, and to particular aspects of Germany, the Philippines, Thailand, Korea and Latin America. The Area Studies Guides are published on 24x reduction microfiche, and are priced at \$1.00 or \$2.00.

AUSINTEL also publishes a large number of Current Awareness Bulletins which list current acquisitions from different countries. The Bulletins are compiled as the material arrives in the library, and before they are fully catalogued; most Bulletins are arranged under broad subject headings. Ishmaelia seems to be about the only foreign country which these Bulletins don't cover.

The Pacific region is covered by a special current awareness bulletin, *Pacific affairs current awareness bulletin*. The first issue of this monthly appeared in April this year. AUSINTEL has also produced a number of bibliographies of material in the NLA in response to specific requests from users, among them a select list of books on Islam and a list of research works on Eastern Europe.
