QUEENSLAND BRANCH

MEMBERS of the 1980 Branch Council met for the first time on 31 January. The President is John Goodell, and the Secretary Susan Acutt. The address for the Branch is PO Box 7, St Lucia 4067. Some topics raised at this first meeting are outlined below.

State Film Centre

The formation of a State Film Centre in Queensland is being discussed by the Education Department and the State Library Board of Queensland. The Branch is organising a submission on the need for the formation of a state-wide film agency, independent of the Department of Education. There is some urgency as space allocations in the new State Library building have almost been finalised.

Recruitment

With 496 members throughout the state, increased membership is seen as a prime objective for 1980. The Past-President, Eric Wainwright, has been appointed Recruitment Officer and is in the process of developing a

plan to get the Association's message across to potential members. However, all present members can do this on an individual basis and as well assist by submitting ideas on increasing membership to the Recruitment Officer.

Continuing Education

A member will be appointed to co-ordinate resources and expertise for continuing education programs in 1980. It was suggested that the person may develop a state-wide clearing house for continuing education projects.

Input

Branch Council would appreciate comment from members on any of the above topics and on the following, which will be raised for discussion in the near future: Development of Public Library Services in Queensland; Free library services for all (LAA policy); Increased co-operation with school librarians and the school library service; Library services to the handicapped.

THE University and College Libraries Section normally sponsors a conference in the year between the LAA biennial conferences. The event for 1980 will be the 'Interlending' Conference to be jointly sponsored by the LAA Queensland Branch and UCLS.

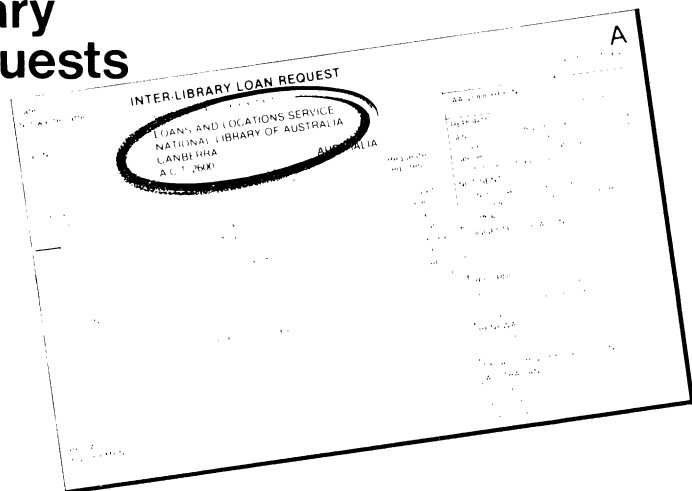
The conference will be held at the University of Queensland from 27-29 August, 1980 and approximately 200 participants are expected to attend.

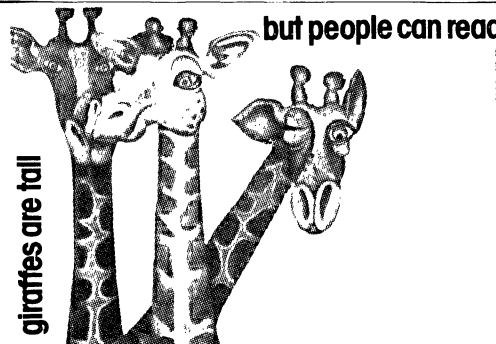
Posters win awards

News from the Audiovisual Committee

THE Audiovisual Services Committee of the LAA after their meeting in Sydney on 13-14 December 1979 report:

1 The committee has received valuable comments on the inter-library code on non-book materials from both the American Library Association and the Library Association of Great Britain. Information received indicates a growing use of the code throughout Australian libraries.

The committee is particularly interested in receiving comments from librarians on the use of the code together with any suggestions for its improvement.

2 During the Biennial Conference of the LAA held in Canberra last year, the committee conducted a special study session on 'Bibliographic organisation of non-book materials'. The session was structured to ensure participants received opportunities to identify matters of importance and develop recommendations in relation to bibliographic organisation of non-book materials in Australia.

The recommendations arising from the special study session were considered in detail by the committee and a paper relating to the matter is being prepared.

3 The committee has completed a statement on *Copyright in Non-book Materials* which has been forwarded to the LAA seeking its endorsement as Association policy.

4 The committee has prepared plans for a portable workshop on micrographics which it hopes to run as part of the Association's continuing education program. A proposal concerning the workshop has been submitted to the Association for consideration.

5 Committee members agreed to prepare items for possible publication in the *Australian Library Journal* and this newsletter during 1980. *Paul McNally*



IN RESPONSE to a number of requests, the Audiovisual Services Committee of the LAA has prepared the following definition for the term 'non-book materials', and recommends its use within the library profession within Australia.

Non-book materials, sometimes referred to as audiovisual or AV materials, include sound and/or visual materials and machine-readable data files 'fixed in any tangible medium of expression, now known or later developed, from which they can be perceived, reproduced, or otherwise communicated, either directly or with the aid of a machine or device'.¹ Such materials include among others the following²:

art original; chart; diorama; filmstrip; flash card; game; globe; kit; machine-readable data file; map; microform, eg aperture card, microfiche, microfilm and microopaque; microscope slide; model; motion picture; picture, eg art print, photograph and poster; realia; slide; soundrecording; technical drawing; transparency; videorecording.

NATIONAL LITERACY TARGET

A JOINT Working Party from the Library Association of Australia and the Australian School Library Association prepared a submission which is now in the hands of the Senate Standing Committee on Education and the Arts.

The submission recommends:

- 1 That the Federal Government announce a national target of 100 percent literacy by the year 2000, and devise policies and fund programs designed to achieve that target;
- 2 That the Federal Government recognise the unique contributions to the national literacy effort that can be made by libraries and actively seek ways to involve the nation's library services in its policies and programs with an appropriate level of funding;
- 3 That the creation of a Literacy Information and Documentation Service be investigated.
