Student recruitment

Margaret Cameron, 1979 Branch President, engaged in an extensive program of talks to students at the various schools of librarianship late last year and this will be followed up with further recruitment meetings early this year.

Education Department consultation

Discussions are taking place with the Department over the apparent reduction in the size of new school library buildings. The Department created a policy recently to build all new schools with a 'core' available for community use and relocatable classrooms. The 'core' is built in permanent materials and includes the library.

The Department also asked the Branch for its views on qualifications suitable for library staff working in primary school libraries. It was referred to appropriate policy statements in the *Handbook*.

The LAA is represented on only two course advisory committees in Victoria – RMIT and Gippsland. Efforts are being made to get representation on the Ballarat and Melbourne State College committees and to be reinstated on the Library Courses (Vocational) Standing Committee (Library Technicians).

Head of Library Services

On 16 November, 1979, Patricia Ward (President), Diana Oliver (General Councillor) and Judy Reed (immediate past President, NSW School Libraries Sectional Group) met Mr Nay, Assistant to the Director General of Education, and Mr Carey, Director of Services, to discuss the Association's concern at the long delay in appointing the new Head of Library Services. The representations made included strong emphasis on the importance of advertising the post as one requiring professional library qualifications as well as management experience and skills. Mr Nay and Mr Carey were left in no doubt as to the importance the Association attaches to this position.

Part-time work and job sharing

Freedom of Information

The final general meeting of 1979 arranged by the NSW Branch was held jointly with the recently formed New South Wales Freedom of Information Council, with which the Branch is now affiliated, on Freedom of Information legislation and, specifically, on the report on the Bill of the Senate Standing Committee.

The report is a substantial one of over 500pp, and the 80 or so people who attended the meeting appreciated Senator Alan Missen's summary of the main features of the report, followed by Senator Chris Puplick's charting of 'where do we go from here?'.

It was emphasised both in the formal speeches and in subsequent discussion that without action by interested public groups the pressures from the public service and from those groups actively interested in maintaining the *status quo* are likely to weigh the balance in favour of the Bill as originally presented.

Librarians were therefore urged to write to the media, to write to their local members (particularly if they are in marginal seats!), to wait on their parliamentary representatives in deputation (and publicise their visit), and to consider a petition.

No MP is able to read, still less digest, all the printed material that comes over his desk, and unless he is made aware from his constituents that they have worries about the legislation there will be no stimulus for debate and action within the parties.

Copies of the press statement issued by Senator Missen, as Chairman of the Senate Committee, when the report was tabled have been distributed by the Branch to public libraries throughout New South Wales (and Senator Missen has emphasised that there are no copyright restrictions on this document). Conference: Interlending in the 80s


