VIEWPOINT

THE UNIVERSITY OF SYDNEY was recently host for the Conference of the Australian National Section for IBBY (International Board on Books for Young People). The theme *Able to Enjoy: Books and the Young Disabled*, was of course in keeping with a particular 1981 emphasis of IYDP.

The aim of the Conference was to show that the disabled child has the ability to live a happy and fulfilling life if given the opportunity. Through practical example, exhortation, encouragement and dedication of speakers and participants a magnificent sense of certainty about that aim became apparent. The singleness of purpose and the ready exchange of example and experience shown by those present who had some more obvious disability than the rest of the participants were constant reminders of the essential equality of the human spirit.

If one theme could be detected from the range of presentations it would perhaps be the individuality of people, whether with a discernible handicap or not. This was typified in the paper by the irrepressible Margaret Marshall in addressing the topic 'Each according to his ability'.

It also came through in most other offerings that there is a tendency to superimpose one's own values on the perceived needs of the disabled; the essential task is to assist in providing access to materials they need or feel they need. Thus the theory of library service to the disabled is not at all different to the theory of library service generally.

Some major inadequacies in the Australian scene were clearly identified. Two which I believe are of significance are in the areas of library education and government funding. On the first point, reflection should make it perfectly obvious that our education programs for library personnel take little cognizance of understanding the needs of the disabled. On the second, a comparison with the United States shows an appalling lack of funding here for programs and research aimed at satisfying the needs of the disabled.

Do we let the matter rest there?

A final word. I was proud to represent our Association at such a refreshingly positive conference. The dedication and commitment of all who provided input was inspirational.

If your report is only a one-page sheet, it is still required. If it is your last copy it will be returned on request. Each contributing library will receive a free microfiche copy of its report.

ALARM is intended:

- To facilitate the widest possible access by practitioners and researchers to library annual reports.
- To stimulate an awareness of the importance of a fundamental form of professional communication.

Does your library have an interest in any area of health, physical education or recreation?
