

# Your views, please!

ONE OF THE matters raised by representatives of AACOBS and LAA during consultations with the Attorney-General's Department was the possibility of including a statutory licence to permit libraries to make multiple copies of print material for users subject to keeping records and paying equitable remuneration to owners of copyright in the works copied if requested by them. Thus the licence would be similar to that provided for in s. 53B.

The response of representatives of the Copyright Agency, the Australian Copyright Council and the Australian Book Publishers Association was that they were agreeable to the suggestion being the subject of further consideration with a view to exploring the possibility of reaching a consensus which the Attorney-General's Department could place before the Attorney-General for his consideration.

It is with this in mind that the Attorney-General's Department is approaching interested parties to ascertain their initial views as to a number of matters that would need to be discussed at the next round of consultations should interested parties wish to give detailed consideration to the contents of a statutory licence for libraries. These matters include:

- (a) extent of copying;
- (b) purpose of copying;
- (c) record making, and
- (d) post record making procedures.

## Extent of copying

The statutory licence for educational institutions in s. 53B places limits on the copying of a work where that work is commercially available.

The Attorney-General's Department would like to know whether interested parties:

- (a) see such limitations as being appropriate in the case of library copying, or
- (b) would agree that the copying of more than a reasonable portion of a commercially available work be made subject to a higher royalty.

## Purpose of copying

Representatives of library interests are consulting with their constituents in order to draw up a list of purposes for which libraries would wish to be able to copy under statutory licence.

Representatives of copyright owners would need to give consideration to copying activities that they would see as not being appropriate for inclusion in a statutory licence. In that context, the Attorney-General's Department have in mind purposes which would put copying in direct competition with commercial exploitation of the work.

An initial indication from interested parties as to the purposes for which copying should be permitted would provide a basis for a detailed discussion.

## Record making

With reference to the record making requirements in s. 53B. These would seem to embody such information as copyright owners require to make claims for remuneration.

In the event that interested parties see any acceptable means of reducing the detail contained therein the Attorney-General's Department are pleased to have suggestions.

There is also the question whether notation of copies made under the proposed licence should be required.

## Post record making procedures

In the case of a statutory licence contained in s. 53B, it is provided in ss. 203A and 203G that the copying institution (or a central records authority) is to hold the records for three years, sort them on an author basis, admit copyright owners to inspect them and make payments in respect of individual claims for remuneration. Penalties are imposed to ensure integrity of the record keeping process.

No duties or obligations are imposed on copyright owners but they are faced with a considerable burden should they exercise their inspection rights in order to claim remuneration.

In view of the level of concern that has been expressed by interested parties in the case of the educational copying procedures, the Attorney-General's Department would like to know whether it is felt that such procedures should apply in respect of a statutory licence for library copying or whether alternatives should be explored.
