Eisenhower Library, The Johns Hopkins University, Baltimore; Julie Virgo, Executive Secretary, Association of College and Research Libraries, American Library Association; John Yocklunn, National Librarian, Papua New Guinea; F. Curtis May, Director of Library Services, San Mateo County Office of Education, California and Charles Robinson, Director, Baltimore Public Library.

Libraries and the Community

*In Baltimore county, we are interested in reading — reading for all purposes — because we feel that reading is a civilizing as well as an indispensable part of modern life. We do not believe in telling people what they should be reading, because we avoid making this kind of value judgment. We rely instead on a policy of supplying to people what they have demonstrated they need and want in their borrowing at our libraries.**

Do you believe that libraries ought to give priority to books of enduring worth? Are you buying copies of *The Holy Blood and the Holy Grail*, the current best-seller, even though it has been slated by the critics?

Do you see the public library's task as providing what the public demands? Are circulation figures the best measure of the value of the library to the community? Is it the librarian's role to tell people what they should be reading?

Can you defend the view that the selection of library materials is made for the potential user today and posterity tomorrow? Is it preferable to read something, whatever its quality, rather than not read at all?

These are some of the questions that sprang to my mind when I read articles by and about Charles Robinson, Director of Baltimore County Public Library. He will address a Plenary session of the LAA Conference on the theme *Libraries and the Community*.

He has worked in public libraries since 1953, and under his directorship, the Baltimore County Public Library has become the most successful in USA in terms of book circulation per capita.

He is very articulate in defence of BCPL policies, and on the subject of intellectual freedom, and his lecture should arouse lively reaction.

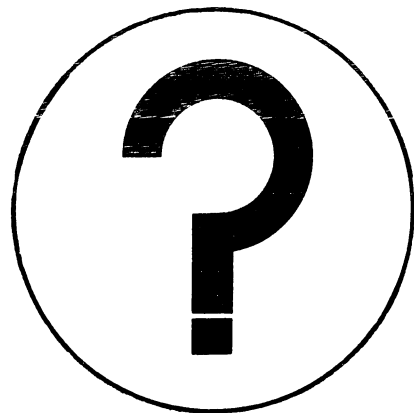
Library systems now available

Pretty NIPpy!

EVERYTHING YOU ALWAYS wanted to know about a National Information Policy, but weren't NIPpy enough to ask is contained in an important new publication from the LAA (ACT Branch).

The proceedings of a seminar held on 7-8 December 1981 have now been published and are being distributed through the LAA.

The aim of the seminar was to bring together the various segments of the information community to discuss what each would like from a NIP.

The government sector identified the difficulties and problems associated with formulating an information policy, including industrial and social issues such as technology, structural adjustment, national control, tariffs, management of infrastructure, employment, privacy, access and copyright, and cultural issues.

The private sector were concerned that an information czar should not be created and that neither they nor the public sector should be prevented from taking appropriate initiatives.

The roles of various organisations such as the recently formed Australian Library and Information Council, AACOBS and the LAA in the development of a NIP were also put forward.
