BISA Workshop

SOME SEVENTEEN librarians from South-East Asia attended a five-day workshop on ASEAN/Australia resource sharing in information retrieval and MARC held at the University of Sydney from 16-20 August 1982.

The workshop, organised by BISA (Bibliographic Information on South-East Asia), was funded by the Australian Development Assistance Bureau (ADAB) and the National Library of Australia (NLA). It was intended to bring senior librarians from the region to Australia to discuss developments suited to resource sharing and to explore ways in which such resource sharing might be made possible.

Those attending included the national librarians of Indonesia (Mastini Hardjo-Prakoso), and Papua-New Guinea (Sir John Yocklunn) and the deputy national librarians of Malaysia (Dr Donald Wijasuriya) Singapore (Yoke-lan Wicks) and Thailand (Suwakhon Phadungath). The director of Indonesia's National Scientific Documentation Centre (Luwarish Pringgoadisurjo) and the chief librarians of Universit Sains Malaysia (Lim Huck Tee), University of the Philippines (Filomena Tann), National University of Singapore (Wai-chee Hochstadt) and the University of Papua-New Guinea (Alan Butler) also attended, as did computer experts from the Asian Institute of Technology (Michael Sherwood) and Universit Sains Malaysia (Lim Chee Hong). Five librarians training in Australia made up the complement of overseas participants, a number of different Australian institutions were represented by librarians.

The workshop was opened by the Director-General of the National Library of Australia (Harrison Bryan), whose address reviewed relationships between Australian and South-East Asian librarians since World War II, giving particular attention to recent developments. The rest of the first day was devoted to hearing country reports from the region, and a report of a regional bibliography of national imprints, the SEAPRINT project.

On the second day a number of talks were given on the Australian situation, Enid Roberts of the Office of Library Co-operation opening the session with an overview. She was followed by Chris Hannan on the Australian Bibliographic Network (ABN); Sue Harvey on CSIRO databases, with specific reference to the Commonwealth Regional Renewable Energy Resources Information System (CRRERIS); and Katie Blake on AUSINET.

Day three covered current activities in resource sharing and proposals for the future. Helen Jarvis discussed the history of BISA, both concerning the database currently available on AUSINET and used for the production of specialised bibliographies on COMfiche, and the training programme associated with production of the database. Since 1980 BISA has been funded by ADAB to train librarians from South-East Asia in database creation and information retrieval. The fourth group of trainees is now commencing their six-month period of secondment

to BISA. Biruta Udris discussed the NLA's international co-operation program, and Allan Horton talked on the library aspects of the Australian Universities' International Development Program (AUIDP).

The afternoon was spent discussing ways in which resource sharing and co-operation might be developed, and the following motions were passed:

- 1) this Workshop urges the continued development of the BISA project, including its training element, and urges BISA to explore the possibility of a more meaningful relationship with NLDC-SEA (National Libraries & Documentation Centres of South-East Asia) or other relevant bodies in the region;
- 2) this Workshop notes that it would be of advantage to Australian libraries, and to the region generally, if consideration could be given to bibliographic data generated in the region being made available to Australian libraries;
- 3) this Workshop notes the desirability of using Australian assistance to fund working visits, including staff exchanges between countries in the region to foster work experience, teaching, training and research in the library and information fields.

In addition, general support was expressed in the workshop for the recommendations made by the Australian committee for Unesco's General Information Program, namely:

that Australia notify Unesco of its desire to participate in the CASTASIA proposal for a regional network for the dissemination and exchange of scientific and technological information and expertise in particular priority areas:

Crucial conference for **Government Film Libraries**

THE FUTURE of documentary film distribution in Australia in times of economic recession was the major theme of the Biennial Conference of the Australian Council of Government Film Libraries, held in Sydney from 20-22 October 1982, and attended by delegates from all States and Territories except Tasmania.

The Council's committee was responsible for Conference planning, agenda, speakers and programming of open sessions. The Conference was hosted by the State Library of New South Wales and organised by staff in the State Film Library, NSW.

The Conference brought together the heads of Australia's network of government film distribution libraries - State Film Centres, Education Department media centres and the National Film Lending Collection of the National Library of Australia. Collectively, these libraries purchase \$1.5 million worth of film each year, carry a range of 35,000 titles, and conduct a total of over 500,000 loans annually. The Libraries are responsible for the lion's share of non-theatrical documentary film distribution in Australia.

Open sessions were attended by representatives of educational organisations, major borrowers and film distributors.

Conference speakers included Don Mc-Kinnon, Senior Administrative Assistant, Premier's Department, NSW who gave the keynote address on the topic 'Service Under Stress – the Eighties Equation'; Des Walsh, National Programme Coordinator, The Australian Bicentennial Authority; Robin Bell, | individuals who are directly concerned with

Principal Legal Officer, Intellectual Property Section, Attorney-General's Department, Canberra, and Ken Archer, Member of the Australian Broadcasting Tribunal.

The launching of the Council's information brochure was followed by a preview screening of The Bounty Experiment, a onehour television special co-produced by Film Australia and the New Zealand Film Unit.

Delegates and guests then attended a reception in the Mitchell and Dixson Galleries of the State Library of New South Wales where they were welcomed by the State Librarian, Russell Doust.

Formation of Australian Database Development Asscn.

At a meeting of interested colleagues on Thursday, 18 November, a new 'Australian Database Development Association' was formed. The following objectives were formulated:

- Provide a forum for exchange of information
- Promote the interests of its members
- Provide a focus for communication with users
- Provide a focus for communication with government and other appropriate bodies
- Formulate policies on the development of Australian databases

Days four and five were spent visiting institutions in the Sydney area illustrating different approaches to automation and cooperation. BISA, University of Sydney Library, New South Wales Institute of Technology (demonstrating CLANN), Macquarie University Library and the University of New South Wales Library were visited by the overseas participants in the workshop.

Some of the visitors then went on to Adelaide to attend LAA22, and the Conference on International Co-operation in Chinese Bibliographical Automation held in Canberra at the end of August.

LAA VOUCHERS for the purposes of interlibrary copying with a face value of three dollars (\$3.00) are now available from the LAA office

These 'vouchers may be purchased in batches of fifty. A handling fee of ten dollars per batch of fifty is charged. This is approximately 6.5 percent.

One dollar vouchers are also available with a handling; fee of five dollars per batch of 50; that is, 10 percent.
