Australian link with IFLA

With IFLA's General Conference to be held in Sydney in 1988, the Association is widening its involvement in the Federation so that there may be better communication and contact between Australian librarians and their colleagues in other countries.

It is therefore most pleasing to be able to announce that three Australians have been elected to Standing Committees of Sections of IFLA. Dr Maxine Rochester of Canberra College of Advanced Education has been elected to the Standing Committee of the Section for Library Schools and other training aspects, Ian McCallum of ACI Computer Services to the Section on Information Technology and Eugenie Greig of Macquarie University to the Cataloguing Section.

It is hoped that news of IFLA activities will be published regularly in *InCite*.

What's on in Queensland

New appointment at **Tasmanian State Library**

Mrs Marita Hargraves, BA, Dip Lib, ALAA, AACS, has been appointed as Research and Development Librarian (RDL) at the State Library of Tasmania. This position was previously held by Ray Bartle, now Assistant State Librarian (ASL).

Marita has been Systems Librarian at the State Library since February 1980, and before this she had worked at the University of Tasmania Library from 1976.

A graduate from the TCAE's School of Librarianship in 1975 with the John Metcalfe prize for outstanding work under her belt, Marita says her new job will include advising the ASL on policy research and policy implementation as well as the establishment of library standards and reviews of performance.

Marita has held the positions of Branch Councillor, Secretary and President of the Tasmanian Branch of the LAA; Secretary of the Tasmanian Branch of the Micrographics Association of Australia and dual examiner for LAA Registration Examinations in reference work

She was Chairman of the State Computer Centre's Users' Group from 1981 to 1983. As Systems Librarian she negotiated policy approval from the Tasmanian Government's Computer Policy Committee for the State Library to purchase a major software and computer hardware package, intended to be used as an integrated in-house system which will control many aspects of library activities currently handled by bureau based systems. She has also evolved the State Library's first EDP Strategic Plan.

Marita will retain responsibility for Systems Planning and Control until the appointment of a new Systems Librarian.

Membership of the Board of Education is as follows:

- three professional members elected by the Professional Committee of General Council:
- seven members, of whom at least four must be professional members, elected by the membership-at-large of the Association;

- the Executive Director as a non-voting executive member.

(Bv-law 24)

The terms of office of three members of the Board end on 30 April 1984. Two members are now to be elected by the membership of the Association to hold office until 30 April 1987. The profes-sional Committee of General Council will elect the third member.

Nominations are hereby called for the two positions. Nominees' must be financial members of the Association. They need not be professional members, however to comply with By-law 24 at least one of the two members elected must be a professional member.

- countersigned by the nominee;
- accompanied by a curriculum vitae (giving full details of academic and professional qualifications) and a statement of concerns, each to be not more than 100 words.
